

Meeting Minutes

October 7th , 2015

The meeting was called to order at 7:30 PM by Rose Aurigemma, President. She thanked all for the hard work and volunteerism at the Great Frederick Fair in September.

There were 40 members in attendance constituting a quorum for the purposes of voting. Our club membership is currently 152 members.

Special Presentation: Wayne Wehling, USDA APHIS on regulatory programs to protect honey bees and other pollinators from invasive pests and diseases

- The Honey Act of 1922 and the Plant Protection Act of 2000 give authority for regulations. APHIS has authority to regulate interstate movement of honey bees, however they do not.
- New Zealand, Australia and Argentina have all sought permission to export honey bees. Australia was granted permission and exported bees to the US from 2005-2008 at which time exporting was stopped due to Apis Cerana (Asian honey bee).
- 3 diseases/pests/viruses currently monitored, but NOT present in the US:
 - Slow Bee Paralysis Virus
 - Apis Cerana (Asian honey bee)
 - Tropilaelaps (a mite smaller than Varroa)
- Prevalence of diseases/pests from National Honey Bee Survey (2009-2014)
 - Varroa Mite found in @90% of samples/ 4.57 mites/100 bees
 - Acute Bee Paralysis Virus found in @20% of samples
 - o Israeli Acute Paralysis Virus found in @10% of samples
 - Nosema found in @54% of samples
 - Deformed Wing Virus found in @85% of samples
 - Chronic Bee Paralysis found in @5% of samples
 - Black Queen Virus found in @60% of samples
 - Lake Sinai Virus (South Dakota) found in @40% of samples
 - Pesticides found in @21% of samples
