

Meeting Minutes

June 3rd, 2015

The meeting was called to order at 7:32 PM by Rose Aurigemma, President at the USDA building at 69 Thomas Johnson Drive.

There were 56 members in attendance constituting a quorum for the purposes of voting. Our club membership is currently 152 members.

Welcome to Tim Hasenei, a new member from Walkersville.

Josie Ritchie, a first grader at Woodsboro Elementary School, gave a brief presentation of her science fair project titled, "That's a Honey of a Different Color." She shared what she learned and displayed her honey spectrum housing 40 samples of honey.

Bee Presentation: Kristien Zaal on Varroa Mite Current Research

Kristien presented information based on current research about Varroa mites and their effects on honey bees and honey bee colonies.

Key Points:

Current recommended treatment threshold is 3 mites per 100 bees. The best way to
determine this number is by using a powdered sugar roll using a Mason jar with a
sample of 100 bees and adding powdered sugar. To determine the relative size of 100
bees compared to various jars:

• The current treatment protocol from University of Maryland:

- Research has identified Varroa Sensitive Hygienic bees (VSH) that have traits and genes that make them more able to fight Varroa.
- What can you do? When buying a queen look for VSH traits to better the chances of survival. Be an informed beekeeper.

New Business:

Hood College Bee Research: Two research assistants requested information from members by completing a survey relative to beekeeping. Each member was given the opportunity to complete and submit the survey. A link to the survey will be sent to members in a few weeks, if you were not in attendance at the meeting.

ESSL Frederick Support: Chuck Schwalbe has been in touch with Jeffrey Grills of the Earth Space and Science Lab (ESSL) in Frederick. The ESSL staff is interested in installing and maintaining an observation hive. They are seeking feedback and advice from willing beekeepers. The members agreed this is a great opportunity to outreach and educate.

Teaching Tub Seminar: Laura Ritchie recognized that requests for educational outreach opportunities are continuing to grow. She offered to lead a teaching seminar using the newly made teaching tub available to club members. She would give a quick overview of how the lessons might look to build member confidence and experience. Rose polled the membership and quite a few members are interested in doing outreach. The seminar will be held prior to a regular meeting most likely in July or August.

Fair Honey Jars: Rose Aurigemma wanted to determine the jar type, size and material for the Fair honey sales. Members may consign their honey during the Fair. Bill McGiffin motioned to raise the price of the honey to \$10/ lb. jar (\$9 for seller, \$1 for club) and keep ½ lb. jars at \$5 (\$4 for seller, \$1 for club) to be aligned with neighboring counties. Joe O'Connell seconded the motion and passed by a majority vote. Members also agreed that glass and plastic queenline style jars will be used in both 1 pound and ½ pound jars. Labels will be provided by the club. Members who wish to use 1 pound and ½ pound bear bottles will need to use the label template to label their own bears with tags or something similar.

The meeting ended with door prizes and snacks (Thanks Rose) and was officially adjourned at 9:07 PM.
